

Posting Rules of *Advances in Resources Research*

1. Purpose

To disseminate scientific and technical findings, theories, knowledge, important experiences, and research results on natural resources (energy, food and, water resources) and related fields widely to academic societies, institutions, and individuals in Japan and overseas, and to contribute to the spread and development of science and technology on natural resources and related fields, publish *Advances in Resources Research (ARR)*.

2. Editorial policy

The content of *ARR* articles shall be useful for the development of science and technology related to natural resources and related fields, and shall be effective for the exchange of knowledge and mutual enlightenment of societies, institutions, and individuals interested in natural resources and related fields. The content of the article is based on new results and has not been published in another publication (except for the authors' patents and preprints).

The language of the article shall be English and the format shall be A4.

3. publication and preservation

ARR is published quarterly in an electronic journal.

The full text of the article is available to anyone at J-STAGE (Japanese Science Technology Information Aggregator, Electronic) for free.

J-STAGE stores a full digital library including *ARR* with a dark archive by Portico. Therefore, when *ARR* is no longer available on J-STAGE, it can be published and used in Portico.

4. Article type

The types of articles are classified as follows.

(1) Original Paper

An original academic study containing new facts or valuable conclusions.

(2) Review Paper

A newly written report on a particular subject, focusing on previously published papers, or a discussion of the authors' findings or findings, including the authors' opinion.

5. Editorial committee

ARR will be compiled by the *ARR* editorial committee by the “editorial policy” outlined in Article 2.

The *ARR* editorial committee is independent of the Resources Economics Research Board, and its structure and activities are subject to the “Editorial Committee Regulations”.

6. Authors and posts

Authors of submitted manuscripts shall be teachers and researchers of universities and research institutes in Japan and overseas, students of doctoral programs in graduate schools, and persons who share the same research philosophy and purpose. One of the authors, who are responsible for responding to peer review and proofreading until publication, is designated as the corresponding author.

Manuscripts shall be submitted by the “Posting Rules” and the “Writing Guidelines” by the designated electronic method.

7. Manuscript for contribution

Submissions should include the authors’ full contribution to the progress and development of science and technology in natural resources and related fields. In addition, the submitted manuscript should not have obvious commercial intent.

Authors must meet all of the conditions set out in the “Posting Rules”. Data that can be published as a single paper cannot be fragmented into multiple studies. When a series of results are submitted as a series of articles, each manuscript is given an independent title, and the title that unifies the whole is given as a subtitle.

The source of the submitted manuscript shall be indicated so that it can refer to related papers in the past, and a full explanation of the novelty of the paper shall be included. Care must be taken not to infringe the copyrights of related articles.

Criticism of existing papers is permitted only for academic advocacy. Criticism should not be made to personally attack authors of existing papers.

Sufficient information shall be provided in the submitted manuscript to allow third parties to reproduce, verify and evaluate the research.

Images must accurately reflect the original data and must not be moved, deleted, added, or highlighted in any particular part. Images may also be processed digitally, but *ARR* editorial committee has the right, if necessary, to require the authors to submit the original image before processing.

Rescission of acceptance, review, and publication of manuscripts in cases of violations of researcher ethics. If it has already been published, the article will be withdrawn.

8. peer review and calibration

The editorial committee reviews the submitted manuscript anonymously by the “Peer Review Guidelines”.

The authors will revise the manuscript as necessary, based on the opinion of the reviewers appointed by the editorial committee. Each time a correction is made, the authors submit a revised draft to the editorial committee along with a written response to the peer review comments. The corrected parts of the revised manuscript are indicated in red.

The adoption of the manuscript shall be based on the opinion of reviewers appointed by the editorial committee.

Manuscripts that are determined not to be published will be returned to the authors with reasons. Authors may submit written comments to the editorial committee if they have an opinion on the decision.

In principle, the submission of this article shall be considered withdrawn if there is no response from the authors or no response within two months from the date of the request from the editorial committee regarding the manuscript requested to be inquired and corrected by the editorial committee.

Proofreading is done once at the first proof or second proof. In principle, correction of contents at the time of calibration is not permitted.

Authors wishing to include errata in *ARR* will submit a written request to the editorial committee within one month of publication. However, the editorial committee will decide whether it is necessary to publish errata.

9. Preprints

ARR recommends that authors submit their manuscripts to community-recognized preprint servers, which includes a preprint server run by JST (Japanese Science Technology), either before or in parallel with the submission.

When submitting a preprinted paper, declare that the manuscript is a preprinted paper. After adoption, it is recommended that the URL of the *ARR* article be displayed in the preprinted article.

10. Copyright

The copyright of articles published in *ARR* (including the right to use derivative works, such as electronic versions) belongs to Resources Economics Research Board from the time the final manuscript is received. Posting articles in academic repositories to which authors belong is permitted only after publication of *ARR* and in the form of PDF files.

ARR is an open-access journal that publishes articles under a Creative Commons Attribution (CC BY) license.

11. Article processing charge

Article Processing Charge (APC) of publishing articles in *ARR* varies by situation. Article of fund assistance pays a fixed APC of US\$500 per fund. Article without financial support is exempt from APC.
